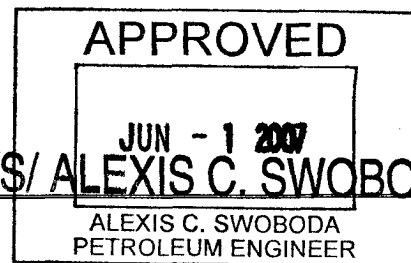
McKay Oil Corporation Plugged and abandoned well on Thursday, August 5, 2004.
