1. Rig up all safety equipment as needed. TOOH with tubing, TAC, S/N, perf sub, mud joint with bull plug and all but 875' of the tubing.
2. Set a 4-1/2" CIBP at 2359' with 35' cement on top.
3. Spot a 100' cement plug across the shoe from 875'-975'. Tag plug.
4. Spot a 100' cement plug across the shoe from 320'-420'. Tag plug.
5. Spot a 100' cement plug from 100' up to the surface. Tag plug.
6. Cut off wellhead and install dry hole marker and clean up location as per regulated.

NOTE: Yates Petroleum Corporation will use steel pits and no earth pits




