8/7/03 Set 3-1/2" 9.2" CIBP at 7974' and cap with 33' cement. Perforate Atoka 7614'-7630' (97).

8/8-10/03 Acidize Atoka 7614'-7630' with 1000g 7-1/2% IC HCL acid.

8/20/03 Frac Atoka with 30,000# 20/40 tempered DC sand.

8/27/03 Set 3-1/2" 9.2" 10K composite plug at 7600'. Perforate Atoka 7502'-7510' (49). Acidize with 750g 7-1/2% IC HCL acid.

9/2/03 Perforate Canyon 6960'-6970' (11). Set 3-1/2" 9.2" AS-1 RBP at 7060'. Acidize Canyon with 2500g 20# Ferchek acid.
