Devon Energy Production Company, LP is applying with the NM OCD for approval to downhole commingle the Red Lake Queen-Grayburg-San Andres (51300) and the Northeast Red Lake Giorieta Yeso (96836) pursuant to 19.15.5.303 (C) 3 (b) Exceptions for wells located in pre-approved pools or areas. This pool was pre-approved by NM OCD Division order PC-1108.

The San Andres is perforated at 1829-2595' and the Yeso is perforated from 2844-3145'. Average production from the SA is 20 oil and 25 gas. Average production from the Yeso is 19 oil and 70 gas.

The allocation method is by ratio of stabilized production. For the Yeso, oil is 48.7% and gas is 73.7%. For the San Andres formation, oil is 51.3% and gas is 26.3%.

Commingle these two pools will not reduce the value of the total remaining production and the ownership between the two pools is identical.
