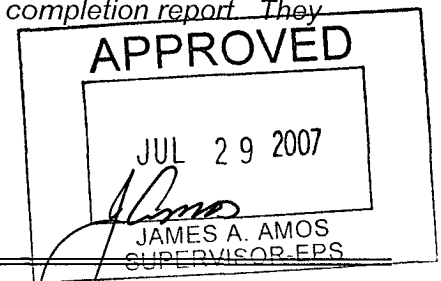

5/4/07 Perforate Wolfcamp 6032'-6034' (6), 6162'-6180' (38), 6318'-6322' (10), 6354'-6358' (10), 6364'-6368' (10) and 6414'-6430' (34). Acidize with 5000g 20% IC acid and 100 balls. 7" AS-1 10K packer with 2.25" on/off tool at 5968'.

NOTE: These perforations should have been Wolfcamp according to the original completion report. They were incorrectly called Cisco on the Notice of Intent submitted on 3/28/07.
