BEPCO, L.P. respectfully requests the approval of off-lease storage and measurement of production from the Golden D Federal #4. Production this wellbore will be metered separately at the Golden "8" Battery prior to being commingled with production from the Golden "8" Federal, the Golden "B" and the Golden Lane "17" Leases. Approval of this request for off-lease storage and measurement will allow for more efficient operations with a Consolidated Battery by reducing the number of stock tanks and water tanks. Using the existing facility will also minimize surface disturbance. Full wellstream production will be transported via flowline to a three phase heater treater where the oil, water and gas will be separated at this vessel. The oil and water will be metered prior to being stored in commingled stock tanks and water tank. The gas will be metered via a separate allocation meter.

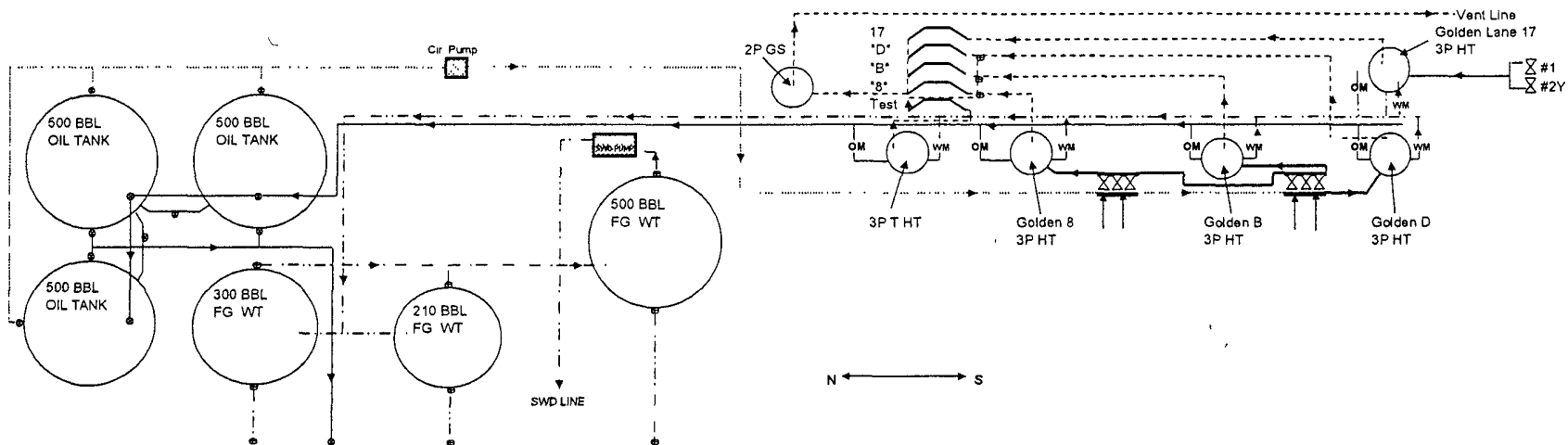
