Tailed in with 200 sx Class "C" + 2% S1 (yld 1.34, wt 14.8). Cement circulated to surface. Tested casing to 900 psi for 30 min. WOC 46 hrs 45 min. Reduced hole and resumed drilling.

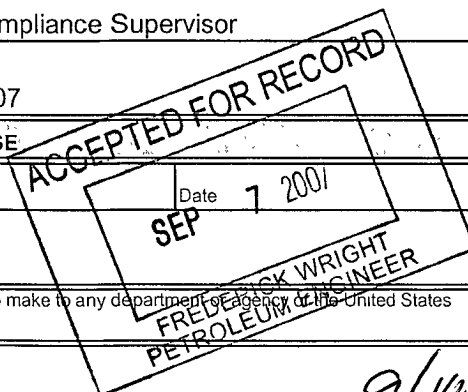
