03.21.07 Ran 13-3/8" 48# H-40 STC to 434.' Cemented with lead of 210 sx Premium Plus + 2% CaCl + 4% Bentonite + 1/8# Poly-e-flake (wt 13.7, yld 1.68) and tail of 220 sx Premium Plus + 2% CaCl (wt 14.8, yld 1.35). Circulated 130 sx to surface.

03.22.07 Rpressure tested 17-1/2" casing to 1000 psi for 30 minutes. WOC total of 27 hours.

03.24.07 In 11" hole, ran 8-5/8" 24# J-55 STC to 1819.' Cemented with lead of 620 sx Interfill C SBM + 0.125# Poly-e-flake (wt 11.9, yld 2.45) and tail of 200 sx Premium Plus + 1% CaCl (wt 14.8, yld 1.33). Circulated 69 sx to surface.

03.25.07 Pressure tested 8-5/8" casing to 2000 psi for 30 minutes. WOC total of 21 hours.
