Fairway Resources Operating, LLC, the current operator of the leases, requests permission to include the Midnight Matador "A" #2 in the commingling approval. Oil and gas production from both leases will be metered at the central tank battery before commingling. Fairway Resources owns all of the working interest in both leases. The attached map shows the two subject leases, the Midnight Matador central tank battery, and affected wells on the leases.

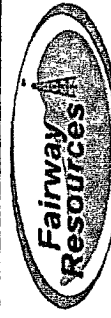
