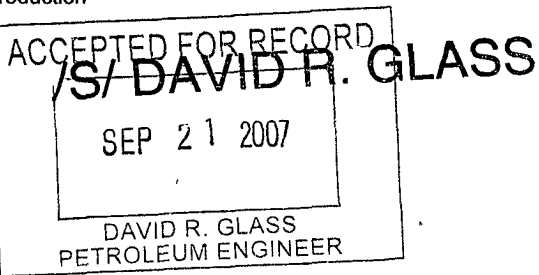

5. remove old rod line system
6. Place well on production
