10/31/07 – Frac Morrow with a CO2 foam frac, 675 bbls fluid, 50,000# 20/40 Versaprop.  
11/4/07 – Set a 4-1/2" 11.6# flow thru composite plug at 11,750'.  
11/5/07 – Perforate Morrow 11,664'-11,670' (37). Acidize with 1000g 7-1/2% HCL acid.  
11/8/07 – Set a wireline composite plug at 11,634'.  
11/11/07 – Perforate Morrow 11,426'-11,430' (25), 11,466'-11,470' (25), 11,494'-11,500' (37), 11,506'-11,510' (25) and 11,532'-11,536' (25). Acidize with 2500g 7-1/2% HCL acid with 200 ball sealers. 4-1/2" AS-1 packer with 1.87" on/off tool and 2-3/8" tubing at 11,279'.
