The existing Morrow perms from 9059-9080' were already isolated by setting a CIBP at 9010' and dump bailing 35' of cement. We set a CIBP at 3515' to isolate the leak at 3561'-3592'. An MIT was successfully performed and the chart is attached.

We are requesting Temporarily Abandon status for this well while we remediate the leak and evaluate for potential pay in the Wolfcamp and Yeso.
