- Approximate temperature of cement when mixed - 75 deg F
- Estimated minimum formation temperature in zone of interest 107.59 deg F
- Estimated cement strength at time of casing test. 680 psi.
- Actual time cement in place prior to starting casing test 9.5 hrs.
