2/7/08 Set 13-3/8" 48# casing at 394'. Cemented with 150 sx Thixotropic and 240 sx Premium Plus + 0.125#/sx Poly-E-Flake + 2% CaCl<sub>2</sub>. Tailed in with 200 sx Premium Plus + 2% CaCl. Cement did not circulate. Temperature survey showed cement at 10' below conductor. Ran 1" cement to surface with 35 sx Premium Plus + 2% CaCl (yld 1.35, wt 14). WOC 32 hrs 10 min. Reduced hole to 12-1/4" and resumed drilling.
