5/01/07 TIH with bailer and tubing. Bailed sand to 2991' TOOH with bailer. TIH with perf subs, tubing, sn ND BOP and NU tree TIH with pump and rods. Hung well on production.  
5/02/07 TOOH with stuck pump TIH with new pump. Hung well on.
