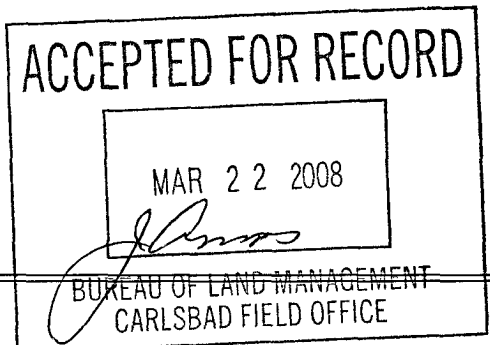

- 12.17.06 POOH w/ tbg & pkr. Set CIBP @ 11480.' Load csg w/ 100 bbl 7% KCl & pressure test to 1500 psi for 30 minutes. Dump bailed 35' cmt on top of plug.
