BEPCO, LP respectfully request permission to temporarily zone abandon the Morrow formation @ 11,498' to 11,656' by setting a 10 K CIBP in the 2-3/8" tubing sub below the current Baker Model D packer set @ ~11,451'. The Atoka formation will then be perforated at 10,941' to 10,954' with approximately 72 holes. The formation will be stimulated w/ 2500 gals. 7.5% HCL w/ additives and put on production in the Atoka formation.

After a period of production to establish well test data, a downhole commingle permit will be sought to produce the wellbore from both the Morrow and the Atoka formations.
