4. POOH w/ 2 3/8" production tubing scanning pipe out of hole. LD any bad joints. Notify engineer of any paraffin or scale on equipment (inside and outside)
5. RU wireline retrieving tool and RIH to 8798' and latch onto whipstock and POOH.
6. PU and RIH with 2 3/8" tubing and RBP pulling tool and wash sand off RBP. Latch RBP set at 8808' and POOH and LD.
7. RIH with 2 3/8" tubing and wash sand off RBP. Latch 2<sup>nd</sup> RBP set at 9100' and POOH and LD.
8. RIH w/ production equipment.
9. RD DDP. and PWOP.

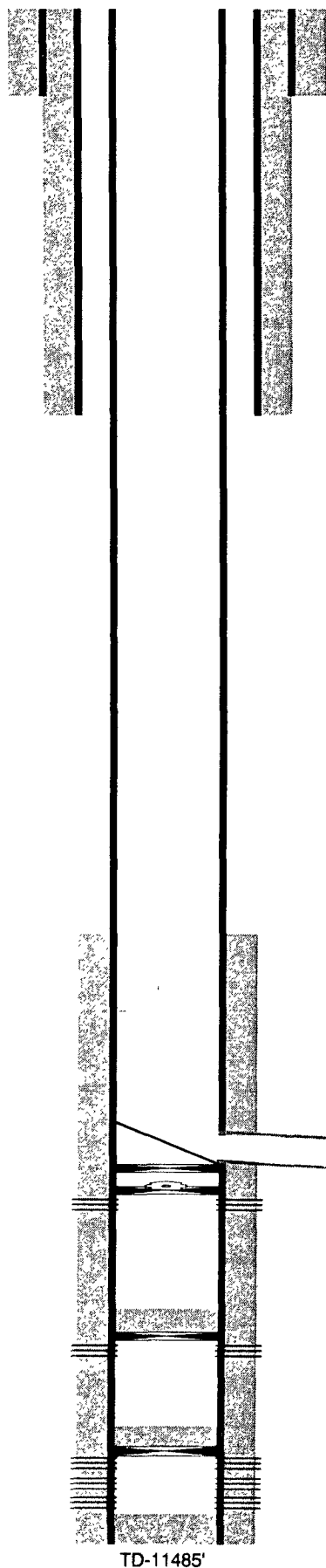

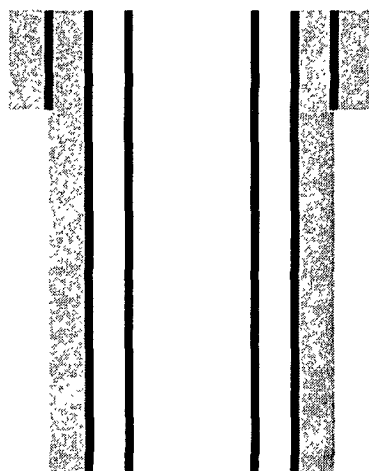
