


Perf the "B" Carb 7536', 7538', 7540', 7542', 7544', 7554', 7556', 7558', 7560', 7562', 7564' (11) and acidize with 2000 gals. NE FE 20% HCL.

Perf the 1st Bone Spring Sand 7191', 7192', 7193', 7194', 7195', 7196', 7338', 7339', 7340', 7341', 7342', 7343', 7409', 7415', 7420' (15) and acidize with 1750 gals. NE Fe 7.5% HCL. If decision to frac, will frac using low gel load crosslink fluid carrying 225,000 lbs sand.

- 1. Contact the BLM at 575-361-2822 prior to commencing work.**
- 2. CIBP at 8545' to have 35' of cement bailed on top or 25 sacks pumped. This will be considered the top of Wolfcamp for plugging purposes and the CIBP will not have to be removed to place plug at top of Wolfcamp.**
- 3. Subsequent sundry required with new production test to be included.**
- 4. Work to be complete by 9/30/2008.**
