Devon Energy Production Company L.P., respectfully requests an extension of our Temporarily Abandoned status that expires on 6/14/08. We also request approval to deepen this well to the Yeso per the following procedure.

1. MIRU pulling unit.
2. PU 4 3/4" mill tooth bit and TIH with assembly.
3. RU reverse unit. Drill out CIBP at 1,560' and shoe joint at 2,407'.
4. Deepen well from 2,449' to 3,500'.
5. Run OH logs.
6. TIH with Peak OH completion tool and tubing.
7. Acidize Yeso
8. RIH with tubing and anchor set at 2,400'.
9. RIH with rods and pump and hang well on production.
10. RDMO pulling unit.

After 9/30/08 the well must be online
or plans to P & A must be submitted.

ACCEPTED FOR RECORD

We plan on deepening this well in August of 2008.

Our field personnel met with Wesley Ingram in January 2008 to discuss this process.
