TIH with treating packer and 2 7/8" tbg, set packer at 1720'

Acidize perforations with 15% NEFE, swab test. POH with tbg and packer.

Fracture stimulate interval via 5 1/2" casing with water gel and sand.

TIH with production tubing, pump, and rods. Pump test upper San Andres Interval.

After obtaining test, POH with completion equipment and retrieve RBP

TIH with production equipment and produce all San Andres intervals.
