On 3-26-08, commenced completion operations. Ran 4-3/4" bit. Drilled out DV tool @ 3,976'. Pressure tested casing to 2,000# - good. Tagged down at 7,055' (float collar at 7,075'). Cleaned out cement to 7,073'.

Rigged up wireline unit. Ran cement bond log. Located top of cement at 104'. Perforated 6693'-6867' (81 holes) and from 6496'-6523' (54 holes).

Acidized with 10,000 gal. of 7-1/2% NEFE HCl. Frac'd via casing with 740,000 gal. gelled brine, 86,451 gal. of 30# linear gel, 185,000# of 40/70 white sand 105,000# of 100 mesh white sand. Installed pumping equipment. Placed well on production.
