TD 12 1/4" hole @ 591' and ran New 8 5/8" 24# J-55 casing equipped with a Texas Pattern Shoe, Insert Float and 4 centralizers to 591. Cemented casing with 350 sx Class C w/ 2% CaCl. Circulated 85 sx to surface and burned the plug @ 7:20 pm 10/26/07.

TD 7 7/8" hole @ 4000' and ran 91 joints new 5 1/2" 15.5# J-55 casing equipped with cement guide shoe, float collar and 10 centralizers to 4000'. Cemented casing w/ 650 sx 65/35 POZ w/ 6% gel and 250 sx C 50/50 POZ w/ 2% gel, plug down at 4:00 am 11/5/07. Cement circulated then fell back. Subsequent CBL showed cement top at 535' (surface casing @ 591')
