BEPCO, L.P. respectfully requests to abandon well bore below 12,084'. During drilling operations drill collars were dropped in the hole and fishing operations were unsuccessful in recovering the drill collars. The hole will be abandoned by placing 175 sacks of Class H cement mixed at 18.0 ppg from 12084' to 11,784'. The well will then be side tracked and re-drilled.
