Mixed @ 14.8 #/g w/ 1.34 yd. Plug down @ 12:45 pm 08/24/08. Circ 93 sks cement to pit. WOC 18 hrs. At 12:01 am on 08/26/08, tested BOPE and casing to 1500# for 30 minutes, held OK. Drilled out with 7 7/8" bit.

09/01/08 TD'ed 7 7/8" hole @ 3500'. Ran 3500' 4 1/2" 11.6# J55 LT&C csg. Cemented w/400 sks BJ Lite Class C (35:65:6) with additives. Mixed @ 12.5 /g w/2.04 yd. Tail with 375 sks Class H with additives. Mixed @ 15.1 /g w/1.29 yd. Plug down @ 1:45 pm 09/02/08. Circ 99 sks cement to pit. At 1:45 pm on 09/02/08, tested csg to 1500# for 30 mins, held OK. Set casing slips w/30k.
