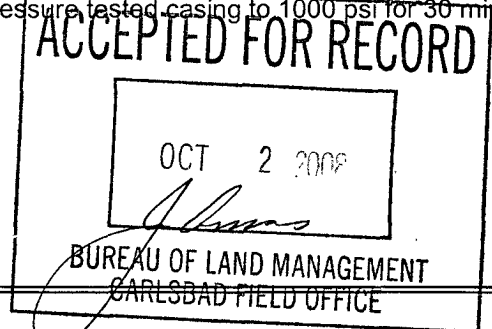
13 Describe Proposed or Completed Operation. Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. 8/27/08 Resumed drilling at 3:00 AM. Set 13-3/8" 48# H-40 casing at 395'. Cemented with 150 sx Thixotropic + 10% CalSeal + 3#/sx Phenoseal + 2% CaCl₂ (yld 1.56, wt 14.5). Tailed in with 420 sx Premium Plus "C" + 2% CaCl₂ (yld 1.35, wt 14.8). Cement did not circulate. Ran temperature survey and found TOC at 150' est. Ran 1" cement to surface with 117 sx Premium Plus "C" cement. Pressure tested casing to 1000 psi for 30 min. WOC 34 hrs. Reduced hole to 12-1/4" and resumed drilling.
