Operator intends to change the rig layout to restrict the well pad to be constructed no more than 100' east of the wellbore, but be enlarged to 250' X 250'. The changed is based on discussions with BLM personell, Pat Flannery and Mike McGee. A 3' berm will be constructed along the east and north side of the wellpad to protect the drainage area on the east side of the wellpad and cave on the northeast corner of the 600'X600'. A copy of a topo map and rig plat are attached.

WHEN OPERATIONS ARE BEING CONDUCTED ON THIS WELL, THE OPERATOR SHALL HAVE THE APD, CONDITIONS OF APPROVAL, AND ALL APPROVED SUNDRY NOTICES ON LOCATION. THESE SHALL BE MADE AVAILABLE UPON REQUEST BY THE AUTHORIZED OFFICER.
