11-1-08 - Ran MIT test to 500 psi w/ no pressure loss and witnessed by NMOCD officer Richard Inge. OCD has the original chart.

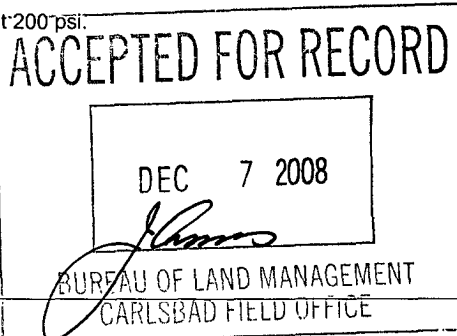
11-7-08 - 11-13-08 - Roustabouts finished work on the tank battery and injection lines.
