11/12/08 TD 17-1/2" hole and set 13-3/8" 48# H-40 ST&C casing at 399'. Cemented with 165 sx Class "C" + D020 + D046 + D903 + S001 (yld 1.98, wt 12.9). Tailed in with 200 sx Class "C" + D903 + S001 (yld 1.34, wt 14.8). Cement circulated to surface. Tested casing to 600 psi. WOC 30 hrs 25 min.

Reduced hole to 12-1/4" and resumed drilling.

11/18/08 TD 12-1/4" hole and set 9-5/8" 36# ST&C casing at 2210'. Cemented with 565 sx Class "C" + 4% D20 + 2% S1 + 0.2% D46 (yld 1.98, wt 12.9). Tailed in with 200 sx Class "C" + 2% S1 (yld 1.34, wt 14.8). Cement circulated to surface. Tested casing to 2000 psi for 30 min. WOC 30 hrs 45 min. Reduced hole to 8-3/4" and resumed drilling.
