Mixed @ 15.8 /g w/1.34 yd did not circ cmt. Ran temp survey indicating TOC @ 150'. PU 1" pipe & tag @ 125'. Cmt 1st plug w/25 sks Class C w/4% CaCl2. WOC 18 hrs. Cmt 2nd plug w/84 sks Class C w/2% CaCl2. Circ 10 sks cement. At 5:30 pm 12/16/08 tested BOPE and casing to 1500# for 30 minutes, held OK. Drilled out with 8 3/4" bit.
