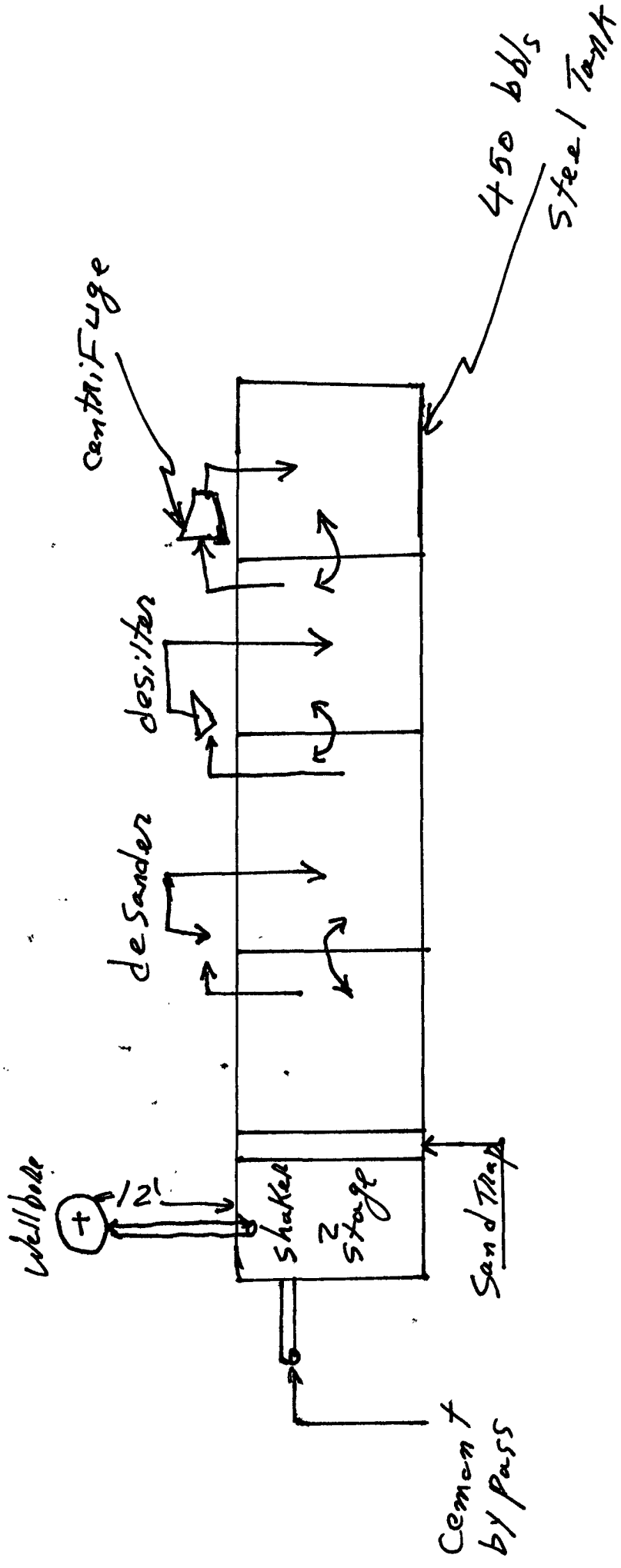

Operation and Maintenance Plan

Solids Control will be inspecting the closed loop system on a daily basis and performing any necessary maintenance. Any leaks/spills will be reported to the NMOCD immediately and cleaned up without delay.
