Mixed @ 14.8 #/g w/ 1.34 yd. Plug down @ 5:15 pm 02/01/09. Did not circ cmt. Slow rate lift pressure @ 70# @ 2 BPM. WOC 6 hrs & ran temp survey. RIH w/1" pipe & tag @ 192'. Cmt 1<sup>st</sup> plug w/25 sks Class C w/6% CaCl2. WOC 18 hrs. Tagged @ 119'. Cmt 2<sup>nd</sup> plug w/25 sks Class C w/6% CaCl2. WOC. Tag @ 105'.
