2/13/09 TD 14-3/4" hole to 712'. Set 11-3/4" 42# H-40 8rd ST&C casing at 700'. Cemented with 200 sx Class "C" with additives (yld 1.97, wt 12.9). Tailed in with 200 sx Class "C" with additives (yld 1.34, wt 14.8). Circulated 100 sx to pit. Tested casing to 1000 psi for 30 min. WOC 29 hrs 15 min. Reduced hole to 11" and resumed drilling.

2/17/09 TD 11" hole to 3130' at 8:30 PM.

2/18/09 Set 8-5/8" 24#, 32# J-55 ST&C casing at 3130'. Cemented with 700 sx Class "C" with additives (yld 1.96, wt 12.6). Tailed in with 200 sx Class "C" with additives (yld 1.33, wt 14.8). Circulated 186 sx to pit. Terry Wilson-BLM witnessed cementing operations. Tested casing to 1500 psi for 30 min. WOC 24 hrs. Reduced hole to 7-7/8" and resumed drilling.
