Tailed in with 200 sx Class "C" + 0.94#/sx CaCl2 (yld 1.34, wt 14.8) Circulated 200 sx to pit. Tested casing to 1500 psi. WOC 26 hrs 35 min. Reduced hole to 7-7/8" and resumed drilling.

1/28/09 Picked up directional tools. KOP at 4200' and continued to drill directionally.

2/8/09 Reached TD 7-7/8" hole 9325'.

Tailed in with 100 sx Class "C" Neat (yld 1.32, wt 14.8)
