1. MIRU all safety equipment as needed. NU BOP.
2. Set a 4-1/2" CIBP at 1232' and cap with 35' cement.
3. Circulate hole with salt gel mud. Spot 25 sx cement plug across the intermediate casing shoe from 1094'-1194'. WOC and tag plug, reset if necessary.
4. Spot 25 sx cement plug across the surface casing shoe from 295'-395'. WOC and tag plug, reset if necessary.
5. Spot 25 sx surface plug from 0-100'. WOC and tag plug, reset if necessary.
6. Cut off wellhead and install dry hole marker and clean location as per regulated.

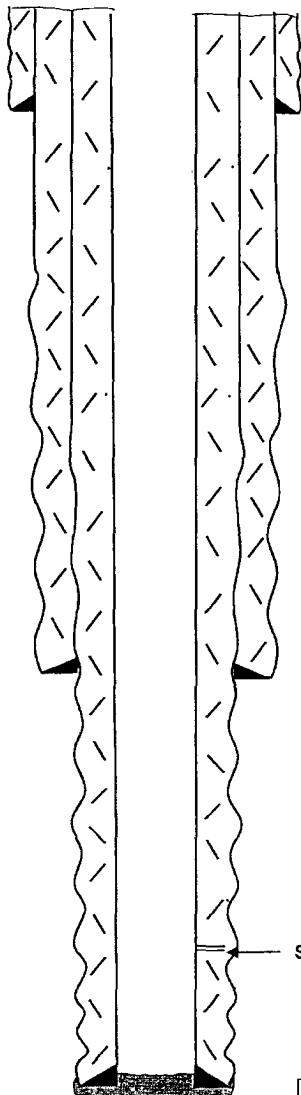

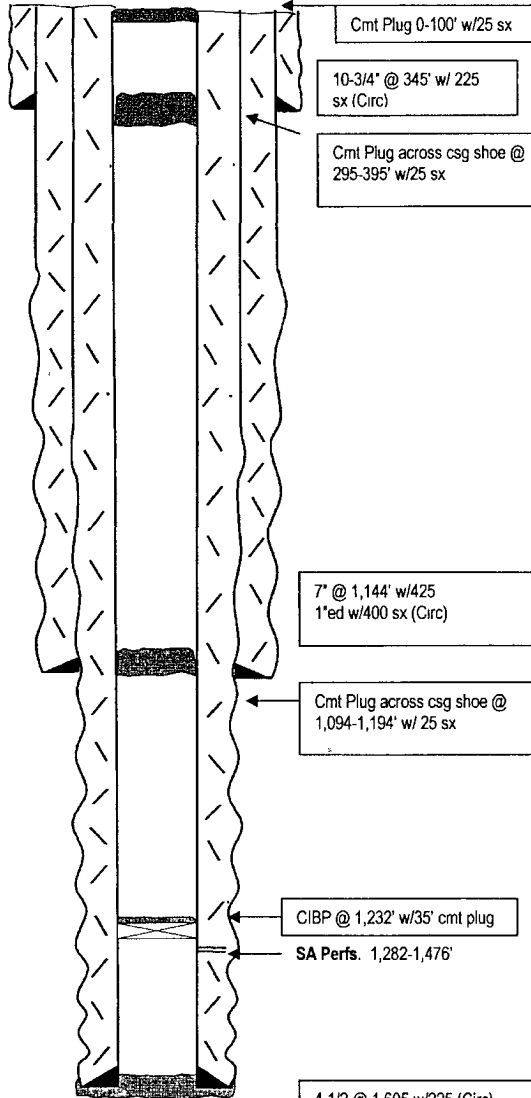
