# SITE FACILITY DIAGRAM

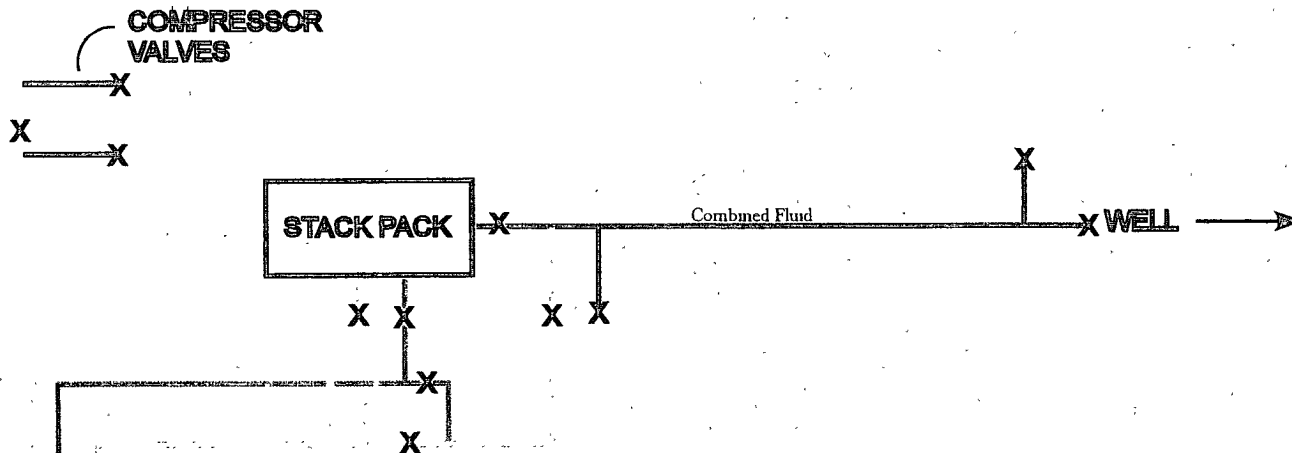
