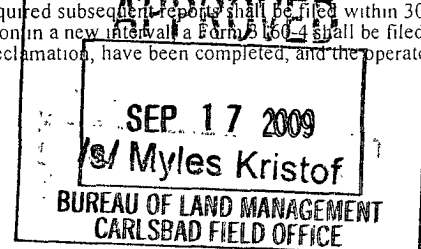

3 Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. - 1 Run and set composite bridge plug 4070', load hole with fresh water; test bridge plug to 1000 psi.
- 2 Pump via 7-5/8" x 10-3/4" annulus fresh water to establish rate/pressure values.
- 3 Pump via 7-5/8" x 10-3/4" annulus 400 sx cement WOC
- 4 Run CBL from PBTD 4070' to surface; test 7-5/8" casing to 1500 psi; evaluate results
- 5 Plan/execute subsequent 7-5/8" x 10-3/4" cement plans, if warranted.
- 6 Drill out bridge plug depth 4070'
- 7 Repair internal well bore below 5792' using conventional cement squeeze methods. Drill out and test.
- 8 Test 7-5/8" casing internally to 1500 psi.
