Perf middle SA @ ~2586'-2727'. Breakdown new pers w/~4500 gals 15% NEFE acid & perf balls. Frac new perfs w/~60,000# 16/30 & 25,000# 12/20 sand in 25# X-linked gel. Set 5-1/2" CBP @ 2560'. PT to 500-1000 psi. Perf upper SA @ ~2024'-2510'. Breakdown new perfs w/~5500 gal 15% NEFE acid & per balls. Frac new perfs w/~160,000# 16/30 & 70,000# 12/20 sand in 25# X-linked gel. Drill out CBPs @ 2560' & 2920' & CO to 3277'. Land 2 1/8" bgs @ ~3110'. Run pump & rods & release workover rig.
