10/08/09 RIH w/tbg to 2487'. RIH w/2" x 1 1/4" x 30' RHBC pump & rods. Put well on production.

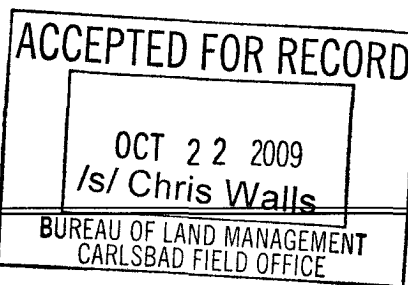
