Spudded well on 9/29/09. Drilled 12-1/4" hole to 405'. Set 8-5/8" 24# J-55 csg @ 392'. Cmted lead w/175 sx (236 cf) "C" cmt w/2% CaCl₂ & 1/8# P-E-Flake & tail w/200 sx (230 cf) "C" cmt w/2% CaCl₂. Circ 170 sx cmt to pit. On 10/1/08, pressure tested 8-5/8" csg to 2000 psi for 30 min - OK.

Drilled 7-7/8" hole to TD3630' on 10/8/09 & set 5-1/2" 17# J-55 production csg @ 3617' w/PBTD @ 3576'. Ran open hole logs. Cmted w/lead 350 sx (662 cf) "C" cmt w/3# salt, 3# gilsonite, & 1/8# P-E-Flake & tailed w/400 sx (532 cf) cl "C" cmt w/1/8# P-E-flake, 0.4% lap-1, 0.5% CFR-3, & 0.25# D-air. Circ 40 sx cmt to pit. Released drilling rig on 10/8/09. Plan to pressure test 5-1/2" csg during completion operations.
