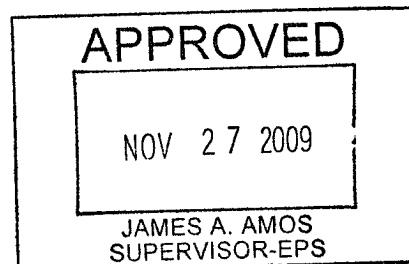

BOPCO, L.P. respectfully requests an additional 90 day extension of the approved P & A procedure, for the subject wellbore, which was originally granted on February 21, 2009. The current P & A procedure expires on November 21, 2009. BOPCO, L.P. is still evaluating the potential of the Delaware formation. The wellbore will be returned to usefulness or P & A'd within 90 days if an extension is granted.

By 2-27-10 the well is to be on production or plugged & abandoned.
