**JUSTIFICATION FOR TEMPORARY ABANDON INSTEAD OF P&A.**

This well was evaluated for possible use as a Cedar Lake Yeso saltwater disposal well; however, it is located 380' from the East lease line. It was not unacceptable to the offset operator of that lease for us to use the Jackson B#41 for saltwater disposal.

This well definitely has pontential for cutting a window in the 7" production casing and drilling a horizontal sidetract in the Glorieta Yeso. Further reservoir and economic evaluation must be done to assess the chance of making a productive well and the economic viability. For this reason this well should be temporarily abandoned to allow evaluation of this well bore. If It is deemed a potentially economic producer, waste of oil and gas reserves will be prevented.

**This well will be completed in the next two (2) years.**
