COG Operating respectfully requests to change the intermediate lead cement from 250 sacks of 50:50:10 (at 11.8ppg) to 600 sacks of Class "C" with 2% CaCl₂ (at 14.8ppg).

The 200 sacks of Class "C" with 2% CaCl₂ will stay the same tail cement as was planned.

This change is due to encountering a water flow in the intermediate hole.
