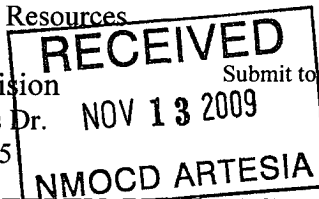

MOC would like to temporarily isolate the Yeso and test the San Andres by setting a retrievable plug over the Yeso. Perforate the San Andres @ 1152' - 2000'. Acidize & swab test for evaluation. If San Andres is commercial, MOC will file for commingle with the Yeso formation and produce both Yeso & San Andres together.

If San Andres is not productive, MOC will squeeze, drill out & place Yeso back to production.

A 3k BOP & H2S monitoring equipment will be used during all operations
