MIRUSU. TOH w/pump, rods, & tbg. Set 5-1/2" CBP @ about 2975' to cover existing Yeso perfs (3031'-3479'). PT 5-1/2" csg to 4500 psi. Perf lower SA @ about 2484'-2911'. Breakdown new perfs w/ about 5000 gal 15% NEFE acid & frac w/ about 113,000# 16/30 & 42,000# 12/20 sand in 25# X-linked gel. Set 5-1/2" CBP @ about 2440'. PT 5-1/2" csg to 4500 psi. Perf middle SA @ about 2010'-2372'. Breakdown new perfs w/ about 5000 gal 15% NEFE acid & frac w/about 97,000# 16/30 & 38,000# 12/20 sand in 25# X-linked gel. CO after frac & drill out CBPs @ 2440' & 2975' & CO to about 3618'. Land tbg @ about 3510'. Run pump & rods & complete as a commingled Yeso - San Andres oil well. Initial production of this commingled well is pending the C-107A commingle application in Santa Fe.
