Yates Petroleum Corporation plans to plug and abandon this well as follows:

- MIRU WSC. Rig up any safety equipment as needed.
- RIH with tubing to 1335', spot 30 sx thixotropic cement across perforations. WOC 2 hrs. Tag plug, reset if necessary.
- RIH with tubing to top of the previous plug and load hole with plugging mud. Spot a 400' (30 sx) Class "C" cement plug across and over the intermediate casing shoe. WOC 3 hrs. Tag plug, reset if necessary.
- RIH with tubing to 400' and spot a 400' (30 sx) Class "C" cement plug across the surface casing shoe and up to the surface from 0-400'. WOC and tag plug, reset if necessary.
- Cut off wellhead, install marker and clean up location as per regulated.




