1. MIRU. WSU. Blow off any pressure present. Lock and tag out all valves
2. POH w/rods and pump. ND wellhead and NU BOP and test.
3. Release TAC, POH w/2-3/8" production tbq. and downhole assembly.
4. CO to +/-50' below perms w/foam unit. Perform scale dissolver/acid stimulation in 2 stages under pkr. Flow or swab back for cleanup, POOH w/pkr.
5. RIH w/production tbq and DHA. RIH w/AL equipment, hang well on. Pressure up, clean location, RDMO.WSU.
