Spud well on 2/11/10. Drilled 12-1/4" hole to 365'. Landed 8-5/8" 24# J-55 csg @ 350'. Cmted lead w/175 sx (236 cf) C cmt w/2% Cacl2 & 1/8# p-e-flake. Tailed w/200 sx (270 cf) C cmt w/2% Cacl2. Circ 129 sx cmt to surface. On 2/11/10, PT 8-5/8" csg to 500 psi for 30 min - OK.

Drilled 7-7/8" hole to TD5355' on 2/26/10. Ran open hole logs. Landed 5-1/2" 17# J-55 csg @ 5341'. Cmted lead w/550 sx (1029 cf) 35/65 poz C cmt w/0.125# p-e-flake, 3# salt, & 3# gilsonite & tailed w/650 sx (864 cf) C cmt w/0.125# p-e-flake, 0.4% Lap-1, 0.5% CFR-3, & 1/4# D-air.
