Lime Rock plans a same zone workover as follows: TOH w/rods, pump, & tbg. Set a 5-1/2" CBP @ about 2785 (above existing San Andres perfs @ 2798'-3257') PT 5-1/2" csg & CBP to 500 psi. Perf additional San Andres interval @ about 2621'-2780'. Breakdown new perfs w/ about 3500 gal 15% NEFE acid & frac w/about 72,000# 16/30 sand & 28,000# 12/20 sand in 25# X-linked gel. CO after frac & drill out CBP @ 2785'. CO through old perfs to about 3491'. Run 2-7/8" tbg & land @ about 3320'. Run pump, & rods & initiate producing load water.
