

RIG UP AND SPUD IN 3-11-2010. DRILLED 17-1/2" HOLE TO 789'. Ran 18 joints (713.55') of 13-3/8", 54.5#, J-55, STC CASING And 2 Joints (78.05') of 13-3/8" 68# J-55 CASING. LANDED CASING @ 791.6', FLOAT COLLAR @ 746.82'.

CEMENT W/SCHLUMBERGER AS FOLLOWS:

PUMPED 20BBLS OF WATER FLUSH

PUMPED LEAD: 450SXS OF "C"+4% D20+.2% D46+1% S1+.125 #/SK D130, 12.9#/ GAL, 1.97 YIELD.

PUMPED TAIL: 200SXS OF C+1% S1 + .125 #/SK D130 14.8#/GAL, 1.34 YIELD.

CIRCULATED 100 SX OF CEMENT TO SURFACE.

WAIT ON CEMENT CUT THE CONDUCTOR AND FOUND THE CEMENT HAD DROPPED 83' (GL). CONTACTED BOB HOSKINSON WITH THE BLM TO GET APPROVAL TO CEMENT THE TOP WITH REDIMIX. AFTER TALKING WITH THE ENGINEER, APPROVAL WAS GIVEN.

WELD ON HEAD AND TEST @ 750 PSI FOR 30 MINUTES. NIPPLE UP BOP

RIG UP AND TEST CASING @ 1,000 PSI FOR 10 MINUTES, TESTED OK.

DRILLED OUT SHOE 29 HOURS AFTER CEMENT IN PLACE.

Contacted Bob Hoskinson W/BLM @ 9:15am GIVING NOTIFICATION OF INTENT TO RUN & CMT CST.
